

## Land Trust Investment

Enclosed are the forms required to complete an investment into a Land Trust with American IRA, LLC.  
**Upon receipt of all documents, in good order, funding will be sent within three (3) business days.**

### Step 1:

**Funding Package:** *Submit documents listed in Step 1 as one complete packet*

- **American IRA Private Entity Investment Form:** Submit Private Entity Investment Form and supporting documents from Trustee
- **To be prepared by Trustee prior to funding:** with proper titling [New Vision Trust Custodian FBO (your name)(your account type)] and initialed by you as “Read and Approved”  
**DO NOT SIGN AS beneficiary**
  - Land Trust Agreement showing your IRA/401k as the beneficiary
